DIRECTIONS TO TRIAL SITE

FROM THE SOUTH:

Take I-43 to Exit 152; turn right (east). Go 3.5 miles to North 8th St (4th stop light); turn left (north). Go 1.2 miles to Albert Drive; Turn right (east). Go 0.7 miles to property

FROM THE WEST:

Take US Hwy 10 to I-43. Cross under I-43 (heading east) & Hwy 10 now becomes Hwy 310. Continue east 3.5 miles to Hwy B (3rd round-about). Turn right (south); go 2 miles to Albert Drive; turn left (east). Go 0.7 miles to property

FROM THE NORTH:

Take I-43 to Exit 154. Turn left (east) onto Hwy 310. Follow "From the West" directions
