

## **Directions:**

### ***From the South:***

Take I-43 to exit 152 (Waldo Blvd) turn East (right) – go 3.5 miles to North 8<sup>th</sup> Street, Turn North (Left) – go 1.2 miles to Albert Dr. Turn East (right) – go 0.7 miles to 40 Albert Dr. on the left.

### ***From the West:***

Take U.S. Hwy 10 to I-43. Road now becomes Hwy 310. Continue East 3.5 miles to Hwy B (3<sup>rd</sup> round about). Turn South (right) – go 2 miles to Albert Dr. go 0.7 miles to 40 Albert Dr. on the left.

### ***From the North:***

Take I-43 to exit 154, Turn East (left) on Hwy 310. Follow “From the West” directions.

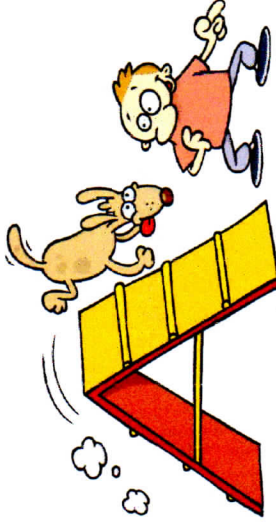
