## **Guest Policy Application**

# Policy:

- Field Members in good standing may sponsor a maximum of two (2) amateur guest members per year.
- · Guest members must be amateur handlers as defined by AKC.
- Wisconsin residents are permitted to be a guest member no more than once in a five-year period.
- Out of state residents are permitted to be a guest member no more than once per year.
- Guests may use the Valders' grounds when in the company of a MCKC field member up to five (5) days in a calendar year.
- The annual fee for a guest member is \$100.
- Guest training is NOT permitted seven (7) days in advance of the Club's annual licensed field trial.
- Field Members and the accompanying guest will be on the honor system and abuse of this policy could result in forfeiture of club privileges to the member.
- It is the responsibility of the sponsoring club member to inform the guest member of the policy and to provide the application to the prospective guest member.
- The completed application shall be forwarded with payment to the field secretary prior to use of the property.

#### Release, Indemnification and Hold Harmless Agreement

In consideration of using the Valders' grounds of the Manitowoc County Kennel Club, and for good and valuable consideration, I hereby agree to release and discharge from liability arising from negligence the Manitowoc County Kennel Club and its directors, officers, agents, members and all other persons or entities acting for them (hereinafter collectively referred to as "Releasees") on behalf of myself and my heirs, assigns, personal representatives and estate, and also agree as follows:

1. I acknowledge that activities inherent with retriever training (the "Activity") involve known and unanticipated risks which could result in physical injury, permanent disability, death, and property damage. Risks include, but are not limited to death or serious injury as a result of being shot or as a result of equipment malfunction; hearing loss; loss of vision; broken bones, bruises and other bodily injuries cause for falls; medical conditions resulting from physical activity and damages clothing or other property. I understand such risks simply cannot be

- eliminated, despite the use of safety equipment, without jeopardizing the essential qualities of the Activity.
- 2. I expressly accept and assume all of the risks inherent in this Activity or that might have been caused by the negligence of the Releasees. My participation in this Activity is purely voluntary and I elect to participate despite the risks. In addition, if at any time I believe that Activity conditions are unsafe of that I am unable to participate due to physical or medical conditions, then I will immediately discontinue participation.
- 3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Releasees from any and all claims and demands, or causes of action which are in any way connective with my participation in this Activity, or my use of the Manitowoc County Kennel Club's equipment of facilities, arising from negligence. Should Releasees be required to incur attorney's fees and costs to enforce this Agreement, I agree to indemnify and hold them harmless for all such fees and costs.
- 4. I represent that I have adequate insurance to cover any injury or damage I may suffer or cause while participating in this Activity, or I agree to bear the costs of such injury or damage myself.
- 5. This Agreement is governed by the laws of Wisconsin. I further agree that if any portion of this Agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.

I have read and understood this Agreement and agree to be bound by its terms.
