**Rally Transfers (will be allowed for these trials)**

After a dog earns a title, it may be transferred to another class in a future trial, even though the closing date for the trial has passed. A transfer (i.e., from an obedience class to an obedience class or a rally class to a rally class) may be requested if, according to the owner's records the handler and dog are eligible and the dog has completed the requirements for the title after the closing date of the trial in which the advanced entry is to be made. The request for a transfer must be in writing and presented to the trial secretary at least 30 minutes prior to the start of each trial. Transfers may be approved provided the class and judge are available, and the class has not reached its limit. Movement between an "A" and "B" class at the same level is not considered a transfer – refer to Chapter 1, Section 16b.

Transfer forms may be downloaded from the AKC website (www.akc.org) and/or will also be available at the secretary's table.

**REFUND OF BITCH IN SEASON**

If your bitch goes into season after the closing date, a full refund of entry fees (less \$8.00 per day for administrative fees) will be given. Such request of refund must be received by the trial secretary no later than the close of the Sunday trial.

**REFUND OF INJURED DOG**

If your dog is injured after the closing date, a refund of entry fees (less \$8.00 per day for administrative fees & all respective AKC fees (per class entered ) ) will be given with written verification from a veterinarian. Such request of refund must be received no later than 7:00 p.m. Monday, November 17, 2025.
